

## Privacy, Terms of Use and Copyright

The rules that are seen as fundamental for ensuring the security of the transactions made by individuals through the Deposit Return Information System and the information used in these transactions are given below. Deposit Return Information System has fulfilled the necessary measures for providing the system and visual infrastructure to the individuals in a reliable manner.

### Security of Personal Data

The information shared by the users with the Deposit Return Information System for the purpose of accessing the services provided in the Deposit Return Information System and updating the personal information is only used by system administrators who are entrusted by the Deposit Return Information System and have access and viewing rights to the system only for ensuring the security and consistency of the Deposit Return Information System.

Information that individuals share with the Deposit Return Information System will be kept for the term allowed by the applicable legislation and will not be shared or given to any third party, institution or organization for any reason whatsoever unless they are approved by the person or the person is under a judicial decision and / or a legal obligation. With no exceptions, this information will not be disclosed unless the situation requires a disclosure of such information with legal regulations.

### Copyright

#### E-Mail and SMS Notifications

All e-mail messages sent from the Deposit Return Information System are sent from **bilgi@dbys.gov.tr**, **noreply@dbys.gov.tr** addresses and SMS messages are sent from **DBYS** or **DARPHANE** short code. In addition, push notifications are sent via our mobile applications. The Deposit Return Information System does not send e-mails or SMS with commercial contents. It does not share the contact information of users with third party persons or institutions. The messages sent from the Deposit Return Information System cover the following contents.

- New Service Releases (Informing the services address the city where you reside or Türkiye in general)
- Informational Messages from Institutions (Official institutions might send informational messages via Deposit Return Information System when there is a situation update about you)
